**ORDINANCE NO. 2021- 04**

**AN ORDINANCE OF THE TOWNSHIP OF LIBERTY, ADAMS COUNTY, PENNSYLVANIA,  
AMENDING THE "LIBERTY TOWNSHIP JUNKYARD ORDINANCE."**

**WHEREAS**, Liberty Township adopted the "Liberty Township Junkyard Ordinance, Ordinance No. 2 of 2005 on June 7, 2005; and

**WHEREAS**, the Liberty Township Board of Supervisors has determined that it is in the best interests and the public, health, safety and welfare of the residents of Liberty Township to have the Junkyard requirements of the "Liberty Township Junkyard Ordinance" amended.

**NOW, THEREFORE, BE IT ENACTED AND ORDAINED**, by the Board of Supervisors of Liberty Township, Adams County, Pennsylvania, that the "Liberty Township Junkyard Ordinance" is amended as follows:

**SECTION 1:** Section 5 shall be amended by the addition of the following after the current second sentence in Section 5:

"Failure to complete all the required information as set forth in Section 4 of this Ordinance in the application shall result in the application being denied. In addition, for renewal applications, no license shall be issued if applicant has been found in violation of this Ordinance three or more times during the preceding term of the license."

**SECTION 2:** Section 3 shall be amended by revising the current second sentence in Section 3 to read as follows:

"The license shall be in effect for a term of one year after issuance of the license by the Liberty Township Board of Supervisors."

**SECTION 3:** Section 4(A)(6) shall be amended by the addition of the following at the end of current Section 4(A)(6):

"If applicant has been in violation of this Ordinance during the preceding term of the license, applicant shall describe in detail the facts concerning said violation/violations."


**SECTION 4:** Repealer and Savings Clause. All parts of the "Liberty Township Junkyard Ordinance, Ordinance No. 2 of 2005", in conflict with this Amendment are repealed. All other parts of this "Liberty Township Junkyard Ordinance, Ordinance No. 2 of 2005", shall remain in full force and effect unless amended by this Ordinance.

**SECTION 5:** Severability: If any article, section, or provisions of this Ordinance should be decided by the Courts to be unconstitutional or invalid, such decision shall not affect the validity of this Ordinance as a whole or any part thereof other than the part so decided to be unconstitutional or invalid.

**SECTION 6:** Effective Date. This Ordinance shall become effective in accordance with the law.
