## A RESOLUTION ADOPTING A PARCEL TO THE TOWNSHIP AGRICULTURAL SECURITY AREA

SECTION 1: The Board of Supervisors of Liberty Township, Adams County, Pennsylvania, established an Agricultural Security Area as permitted by the Agricultural Security Law within the Township by Resolution on May 5, 1992.

SECTION 2: The Board of Supervisors from time to time receives request for additional land to be added to the Agricultural Security Area.

SECTION 3: The Board of Supervisors received a request on May 2, 2018 to add lands of Joseph and Kellie Macharsky, Tax Parcel No. 25D17-0001---000.

SECTION 4: The Board of Supervisors did not act to adopt or reject the Proposal, or any modifications, within 180 days of the date of the Proposal was originally submitted to the Township.

SECTION 5: Section 908 of the Agricultural Area Security Law provides that the failure of the municipality to act within the 180-day period shall be deemed an adoption of the Proposal without modification.

SECTION 6: The Board of Supervisors of Liberty Township enacts this Resolution for the purpose of completing the necessary procedures to add the lands of **Joseph and Kellie Macharsky**, **Tax Parcel No. 25D17-0001---000** to the Township Agricultural Security area.

SECTION 7: The following properties are hereby added to the Agricultural Security Area in Liberty Township, Adams County, Pennsylvania:

SECTION 8: This document shall be recorded in the Office of the Recorder of Deeds in and for Adams County, Pennsylvania


