January 4, 2021 Board of Supervisors Meeting Minutes

The Board of Supervisors of Liberty Township, of Adams County, met Monday, January 4, 2021 at 7:47 PM, directly following the Reorganization Meeting at the Township Municipal Building located at 39 Topper Road, Fairfield, PA 17320. Because of the COVID-19 Pandemic, social distancing measures were taken. Public in person attendance was limited to four people. The meeting was streamed live on Liberty Township's YouTube Channel. A call-in number was provided for public comment.

Present: Chairman Walter Barlow, Vice Chairman Robert Jackson, Supervisor Robert Keilholtz, Solicitor John Lisko, Police Chief Sherri Hansen, and Secretary/Treasurer Wendy Peck.

At 8 PM Mr. Barlow called the regular meeting to order and gave information on the call-in line and video broadcast for the meeting. He then opened the meeting to public comments.

Mr. Keilholtz moved for acceptance of the Treasurer's report. Mr. Jackson seconded the motion. All voted yes, and the motion passed.

Expenses: Mr. Keilholtz moved for acceptance of the 12/01/20-01/04/2021 Expenses and Payroll for 11/22/20-12/05/2020 - retroactive, 12/06/20-12/19/2020 - retroactive); and 12/20/20-01/02/2021. Mr. Jackson seconded the motion. All voted yes, and the motion passed.

<u>Police Officer's Report</u> – Chief Sherri Hansen distributed a written report to the Supervisors for the month of December which included working 249 hours, driving 1542 miles, issuing 65 traffic citations, and 13 warnings. She announced that a policy and procedures manual was completed for the police department and all officers will receive a printed and digital copy. The Chief also reported that she completed performance evaluations for the officers.

Zoning Officer's Report – Mr. Barlow reported that six zoning permits were issued in December 2020 with \$455 permit fees collected. Mr. Barlow reported that the Palmer property cleanup extension had expired on December 31 and that Mr. and Mrs. Palmer had requested additional time to complete the work. Mr. Barlow stated that he did see improvement lately on the cleanup and the Supervisors discussed the issue in detail. Mr. Barlow made a motion to allow an additional 90 days before proceeding with zoning violations provided monthly inspections of the property still show improvement. Mr. Keilholtz seconded the motion. All voted yes, and the motion passed.

Roadmaster Report — Mr. Barlow reported that a sign inventory was taken and approximately 145 signs need to be replaced to bring them in to compliance with PennDOT regulations. The estimated cost is \$4,350 for the signs and \$4,200 for the breakaway sign posts. He also reported on activities that included snow removal, tree trimming, culvert cleaning, washing, and servicing trucks, and responding to an accident. Mr. Barlow stated that he spoke to Hamiltonban Township and was quoted a price of \$119 per hour for one man and machine for cutting with a high reach mower. The Supervisors discussed the sign replacement in detail. Mr. Barlow made a motion to move forward with the replacement of the signs. Mr. Jackson seconded the motion. All voted yes, and the motion passed.

<u>Planning Commission Report:</u> Planning Commission Chair Judie Hogan reported via telephone. She stated that the Planning Commission has been meeting by zoom on one of the member's personal accounts and asked that the township subscribe to a Zoom account for the Planning Commission to use. She estimated that it would cost about \$15 per month. Mr. Barlow made a motion to sign up for a zoom account. Mr. Jackson seconded the motion. All voted yes, and the motion passed. The Planning Commission did not meet in December.

Liberty Township, Adams County, PA BOS Meeting Minutes

<u>Secretary/Treasurer:</u> Ms. Peck reported that she received a request for reimbursement from Natalie Williams for mileage and hours for tax collector training of Jessica Ilko. Mr. Barlow asked that it be added to the February meeting agenda to allow time for the Board to review the matter.

Old Business

- Christ Apostolic Church 25A18-0007---000 Real Estate Tax Assessment Settlement Agreement Mr. Barlow made a motion to authorize the Solicitor sign the settlement agreement once it was signed by Fairfield Area School District. Mr. Jackson seconded the motion. All voted yes, and the motion passed.
- Fire Tax Distribution Mr. Barlow gave an overview of conversations that he had recently with the Solicitor, the fire departments, AREMS and Kevin Moul. In summary, the current fire tax cannot be distributed to ARMES this year and the fire tax distribution has been readjusted. Mr. Barlow made a motion to distribute the fire tax as follows with the reimbursable amounts allowed with the submitted invoices: Fairfield Fire Department \$16,131.75, Fountaindale Fire Department \$6,178.12, and Vigilant Hose of Emmitsburg \$12,013.01. After much discussion, Mr. Jackson seconded the motion. All voted yes, and the motion passed.

New Business Public Comment - None.

<u>New Business:</u> Chairman Barlow changed the order of the agenda items to address the fee schedule prior to the Junkyard Permit Application.

- Resolution 2021-04 Resolution 2021-04 Amend Fee Schedule Mr. Barlow discussed the amended fee schedule and explained the justification for the elimination of the demolition fee and the increase in the Junkyard Permit fee. After much discussion, Mr. Barlow made a motion to adopt Resolution 2021-04 Resolution 2021-04 Amend Fee Schedule. Mr. Keilholtz seconded the motion. All voted yes, and the motion passed.
- Mr. Barlow made a motion to adopt Resolution 2021-01 Eliminating Employee Contributions to The Police Pension Plan For 2021. Mr. Jackson seconded the motion. All voted yes, and the motion passed.
- Mr. Barlow made a motion to adopt Resolution 2021-02 Repealing the Fire Service/EMS Tax Resolution No. 2014-R-3 and
 rolling the Fire Tax Budget in to the General Fund. It was noted that no changes were made to the overall real estate taxes,
 the total budget income, or expenses. Mr. Keilholtz seconded the motion. All voted yes, and the motion passed.
- Mr. Barlow made a motion to adopt Resolution 2021-03 Adams County Hazard Mitigation Plan Adoption. Mr. Keilholtz seconded the motion. All voted yes, and the motion passed.
- Review Junkyard Permit Application dated 12/07/2020 for 245 Waynesboro Pike #25C18-0074---000 The Board reviewed the Piper application for a junkyard permit. After much discussion it was determined that the application was not filled out accurately. Mr. Barlow made a motion to return the Piper Junkyard application and fee and allow Mr. Piper to reapply correctly and with the new fee that was set for 2021. Mr. Keilholtz seconded the motion. All voted yes, and the motion passed.
- Mr. Barlow made a motion to adopt Ordinance 2021-01 Earned Income And Net Profits Tax Ordinance. Mr. Jackson seconded the motion. All voted yes, and the motion passed.
- Mr. Barlow made a motion to Set Mileage Rate for Township Mileage Reimbursement to the Federal Rate 56 cents per mile for 2021 with the option to reconsider if the Federal Rate Changes. Mr. Keilholtz seconded the motion. All voted yes, and the motion passed.
- Mr. Barlow made a motion to advertise Road Project Bids for 2021. Mr. Keilholtz seconded the motion. All voted yes, and the motion passed.
- Consider a motion to award HVAC installation for Township Municipal Building- Mr. Barlow made a motion to award the HVAC installation bid to the Key Services for a total cost of \$9,280. Mr. Keilholtz seconded the motion. All voted yes, and the motion passed. Mr. Barlow made a motion to pay the 50% deposit of \$4,640 and schedule the service. Mr. Keilholtz seconded the motion. All voted yes, and the motion passed.
- Appoint representatives and alternate representatives to attend meetings and vote on behalf of Liberty Township for YATB,
 Adams County Tax Committee, ACBA, ACCOG, ACCOG Legislative Committee, FREMA, Area Fire Companies and Attendance at ACATO and PSATS Conferences. The Supervisors agreed to continue rotating attendance at the meetings.
- Mr. Barlow made a motion to not oppose distribution from the Tax Upset Sale. Mr. Keilholtz seconded the motion. All voted ves, and the motion passed.

At 8:58 PM Mr. Barlow made a motion to adjourn the meeting. Mr. Keilholtz seconded the motion. All voted yes, and the motion passed.

The next public meeting is scheduled for Tuesday, February 2, at 7:30 PM at the Township Municipal Building.
